

On the Asymptotic Behavior of Eigenvalues and Eigenfunctions of the Robin Problem with Large Parameter

Abstract. We consider the eigenvalue problem with Robin boundary condition $\Delta u + \lambda u = 0$ in Ω , $\partial u / \partial \nu + \alpha u = 0$ on $\partial \Omega$, where $\Omega \subset \mathbb{R}^n$, $n \geq 2$ is a bounded domain with a smooth boundary, ν is the outward unit normal, α is a real parameter. We obtain two terms of the asymptotic expansion of simple eigenvalues of this problem for $\alpha \rightarrow +\infty$. We also prove an estimate to the difference between Robin and Dirichlet eigenfunctions.

Keywords: Laplace operator, Robin boundary condition, eigenvalues and eigenfunctions, large parameter, asymptotic behavior.

1 Introduction

Let $\Omega \subset \mathbb{R}^n$, $n \geq 2$ be a bounded domain with boundary Γ of class C^3 . Consider the eigenvalue problem

$$\Delta u + \lambda u = 0 \quad \text{in } \Omega, \quad (1.1)$$

$$\frac{\partial u}{\partial \nu} + \alpha u = 0 \quad \text{on } \Gamma, \quad (1.2)$$

where ν is the outward unit normal vector to Γ , α is a real parameter. By $\{\lambda_k(\alpha)\}_{k=1}^{\infty}$ we denote the sequence of eigenvalues of the problem (1.1), (1.2)

enumerated as

$$\lambda_k(\alpha) = \sup_{v_1, \dots, v_{k-1} \in L_2(\Omega)} \inf_{\substack{v \in H^1(\Omega), \\ (v, v_j)_{L_2(\Omega)} = 0, \\ j = 1, \dots, k-1}} \frac{\int_{\Omega} |\nabla v|^2 dx + \alpha \int_{\Gamma} v^2 ds}{\int_{\Omega} v^2 dx}, \quad (1.3)$$

for $k = 1, 2, \dots$ and by $\{\lambda_k^D\}_{k=1}^{\infty}$ denote the sequence of eigenvalues of Dirichlet problem

$$\Delta u + \lambda u = 0 \text{ in } \Omega, \quad u = 0 \text{ on } \Gamma, \quad (1.4)$$

enumerated respectively

$$\lambda_k^D = \sup_{v_1, \dots, v_{k-1} \in L_2(\Omega)} \inf_{\substack{v \in \mathring{H}^1(\Omega) \\ (v, v_j)_{L_2(\Omega)} = 0 \\ j = 1, \dots, k-1}} \frac{\int_{\Omega} |\nabla v|^2 dx}{\int_{\Omega} v^2 dx}, \quad (1.5)$$

for $k = 1, 2, \dots$

By $\{u_{k,\alpha}(x)\}_{k=1}^{\infty}$ and $\{u_k^D(x)\}_{k=1}^{\infty}$ we denote the corresponding sequences of normalized in $L_2(\Omega)$ Robin and Dirichlet eigenfunctions (all considered functional and abstract spaces will be real spaces). It is known that the eigenvalues $\lambda_1(\alpha)$ and $\lambda_1^D > 0$ are simple and $\lim_{k \rightarrow \infty} \lambda_k(\alpha) = \lim_{k \rightarrow \infty} \lambda_k^D = +\infty$. It follows from (1.3), (1.5) that $\lambda_k(\alpha) \leq \lambda_k^D$. As it was noted in ([3], Chapter 6, Section 2, Subsection 1) for $n = 2$ in the case of a smooth boundary Γ we have $\lim_{\alpha \rightarrow +\infty} \lambda_k(\alpha) = \lambda_k^D$, $k = 1, 2, \dots$. Later in [19] for $n = 2$ the following two-side estimates for the first eigenvalue $\lambda_1(\alpha)$ were obtained

$$\lambda_1^D \left(1 + \frac{\lambda_1^D}{\alpha q_1}\right)^{-1} \leq \lambda_1(\alpha) \leq \lambda_1^D \left(1 + \frac{4\pi}{\alpha |\Gamma|}\right)^{-1}, \quad \alpha > 0,$$

where q_1 is the first eigenvalue of Steklov problem

$$\begin{aligned} \Delta^2 u &= 0 && \text{in } \Omega, \\ u &= 0, \quad \Delta u - q \frac{\partial u}{\partial \nu} &= 0 && \text{on } \Gamma. \end{aligned}$$

In [7, 8], the estimates for all eigenvalues were proved

$$\lambda_k^D - C_1 \frac{(\lambda_k^D)^2}{\sqrt{\alpha}} \leq \lambda_k(\alpha) \leq \lambda_k^D, \quad \alpha > \alpha_1 > 0 \quad (1.6)$$

where constants C_1 and α_1 are independent on k . In [9] the estimates (1.6) were sharpened:

$$\lambda_k^D - C_2 \frac{(\lambda_k^D)^2}{\alpha} \leq \lambda_k(\alpha) \leq \lambda_k^D, \quad \alpha > \alpha_1 > 0. \quad (1.7)$$

The case $\alpha < 0$ has recently attracted attention in connection with diffusion models [12]. It was shown in [12] that for piecewise C^1 class boundary

$$\liminf_{\alpha \rightarrow -\infty} \frac{\lambda_1(\alpha)}{-\alpha^2} \geq 1,$$

and in particular when $\Omega \subset \mathbb{R}^2$ is a triangle with inner half-angles $\alpha_1, \alpha_2, \alpha_3$ the authors have proved that

$$\lim_{\alpha \rightarrow -\infty} \frac{\lambda_1(\alpha)}{-\alpha^2} = \max_{1 \leq j \leq 3} \operatorname{cosec}^2 \alpha_j > 1.$$

In [14] for C^1 class boundaries the following equality was proved

$$\lim_{\alpha \rightarrow -\infty} \frac{\lambda_1(\alpha)}{-\alpha^2} = 1. \tag{1.8}$$

These results indicate that the asymptotic behavior of $\lambda_1(\alpha)$ for $\alpha \rightarrow -\infty$ is strongly affected by the smoothness of the boundary and C^1 class is optimal for the equality (1.8). In [4] it was proved that for C^1 boundaries for all $k = 1, 2, \dots$ we have

$$\lim_{\alpha \rightarrow -\infty} \frac{\lambda_k(\alpha)}{-\alpha^2} = 1.$$

The second term of asymptotics of $\lambda_k(\alpha)/(-\alpha^2)$ was found in [5] for $n = 2$ with $\Gamma \in C^4$ and later in [17] for $n \geq 2$ with $\Gamma \in C^3$:

$$\frac{\lambda_k(\alpha)}{-\alpha^2} = 1 - (n - 1)H_{\max}\alpha^{-1} + O(|\alpha|^{-4/3}), \quad \alpha \rightarrow -\infty \tag{1.9}$$

with $H_{\max} = \max_{x \in \Gamma} H(x)$ where $H(x)$ is the mean curvature of the surface Γ oriented by inner normal at the point x . It was proved in [17], that if, additionally, $\Gamma \in C^4$, then the reminder estimate $O(|\alpha|^{-4/3})$ can be replaced by $O(|\alpha|^{-3/2})$. Let us note the result of [7], where the lower estimate for the derivative of the first eigenvalue $\lambda'_1(\alpha)$ were obtained:

$$\liminf_{\alpha \rightarrow -\infty} \frac{\lambda'_1(\alpha)}{-\alpha} \geq 1.$$

2 Main results

By $m(\lambda)$ we denote the multiplicity of eigenvalue λ .

Theorem 1. *For any $k = 1, 2, \dots$ there exists the number $\alpha_k \in \mathbb{R}$ such that for $\alpha > \alpha_k$ we have*

$$m(\lambda_k(\alpha)) \leq m(\lambda_k^D).$$

Theorem 2. *Let $m(\lambda_k^D) = 1$. Then there exists the number $\alpha_k \in \mathbb{R}$ such that for all $\alpha > \alpha_k$ the eigenvalue $\lambda_k(\alpha)$ is a differentiable function and*

$$\lambda'_k(\alpha) = \frac{\int_{\Gamma} u_{k,\alpha}^2 ds}{\int_{\Omega} u_{k,\alpha}^2 dx} > 0. \tag{2.1}$$

Theorem 3. *Let $m(\lambda_k^D) = 1$. Then the eigenvalue $\lambda_k(\alpha)$ obeys an asymptotic expansion*

$$\lambda_k(\alpha) = \lambda_k^D - \frac{\int_{\Gamma} \left(\frac{\partial u_k^D}{\partial \nu}\right)^2 ds}{\int_{\Omega} (u_k^D)^2 dx} \alpha^{-1} + o(\alpha^{-1}), \quad \alpha \rightarrow +\infty. \tag{2.2}$$

We can see that

$$\int_{\Gamma} \left(\frac{\partial u_k^D}{\partial \nu} \right)^2 ds > 0. \quad (2.3)$$

If not, the eigenfunction u_k^D is a solution of the Cauchy problem

$$\Delta u_k^D + \lambda_k^D u_k^D = 0 \text{ in } \Omega, \quad u_k^D = \partial u_k^D / \partial \nu = 0 \text{ on } \Gamma.$$

So, $u_k^D \equiv 0$ ([11], Chapter 1, Theorem 1.46). This is impossible. The relations (2.2), (2.3) show that the first power of α in the denominator of (1.7) cannot be replaced by $\alpha^{1+\delta}$ with any $\delta > 0$.

Remark. For the first eigenvalue the expansion (2.2) was obtained in [6].

The next theorem establishes the rate of convergence of the eigenfunction $u_{k,\alpha}$ of the Robin problem (1.1), (1.2) to the eigenfunction u_k^D of the "limit" Dirichlet problem (1.4) at $\alpha \rightarrow +\infty$. For any $\alpha \in \mathbb{R}$ we suppose $\int_{\Omega} u_{k,\alpha} u_k^D dx \geq 0$.

Theorem 4. *Let $m(\lambda_k^D) = 1$. Then there exists the number $\alpha_k \in \mathbb{R}$ such that for all $\alpha > \alpha_k$ we have $m(\lambda_k(\alpha)) = 1$ and*

$$\|u_{k,\alpha} - u_k^D\|_{H^2(\Omega)} \leq M_k / \alpha \quad (2.4)$$

where the constant M_k is independent of α .

Let us notify the difference of asymptotic behavior of eigenvalues in our case $\alpha > 0$ (repulsive Robin condition) with the case $\alpha < 0$ (attractive Robin condition). Here for smooth boundary the global properties of the eigenfunctions (2.4) determine the second term of the asymptotics (2.2), while in the attractive case the second term of the asymptotics (1.9) is determined by a local behavior of the boundary around the points of the maximum mean curvature.

3 Perturbation of eigenvalues

We use the following inequality ([16], Lemma 51.1).

Theorem 5. *Let A and B be two linear self-adjoint, compact and positive operators on a separable Hilbert space H . Let μ_k^A and μ_k^B be their eigenvalues, enumerated in the decreasing order according to their multiplicity. Then*

$$|\mu_k^A - \mu_k^B| \leq \|A - B\|. \quad (3.1)$$

For $h(x) \in L_2(\Omega)$ consider the weak solution $u(x) \in H^1(\Omega)$ of the Robin boundary value problem

$$-\Delta u + u = h \quad \text{in } \Omega, \quad (3.2)$$

$$\frac{\partial u}{\partial \nu} + \alpha u = 0 \quad \text{on } \Gamma, \quad \alpha > 0. \quad (3.3)$$

In domain with C^2 class boundary surface we have $u \in H^2(\Omega)$ ([15], Chapter 4, Section 2, Theorem 4). For our proofs we need an elliptic estimate ([9], Theorem 3) to solution of the problem (3.2), (3.3) at large values of α .

Theorem 6. *The solution of the problem (3.2), (3.3) satisfies the estimate*

$$\|u\|_{H^2(\Omega)} \leq C_3 \|h\|_{L_2(\Omega)}, \quad \alpha > \alpha_1 > 0 \tag{3.4}$$

with the constant C_3 is independent of α .

Remark. Let us note that the estimates of type (3.4) to solution of the problem (3.2), (3.3) were previously obtained for fixed α (see, for example, [15]). But we need the estimate (3.4) valid with one constant C_3 for $\alpha \rightarrow +\infty$.

For Robin problem (3.2), (3.3) we define the linear operator A_α by

$$A_\alpha : L_2(\Omega) \rightarrow H^1(\Omega) \subset L_2(\Omega) \text{ for } h \mapsto u.$$

The operator A_α is a self-adjoint positive compact operator in $L_2(\Omega)$ ([8], Section 4) and $\|A_\alpha\| = 1/(\lambda_1(\alpha) + 1) < 1$. Now,

$$(\lambda_k(\alpha) + 1)A_\alpha u_{k,\alpha} = u_{k,\alpha},$$

thence

$$\mu_k(\alpha) = 1/(\lambda_k(\alpha) + 1) \tag{3.5}$$

are the eigenvalues of A_α with the eigenfunctions $u_{k,\alpha} \in H^1(\Omega)$.

Let $w = (A_{\tilde{\alpha}} - A_\alpha)h = \tilde{u} - u$. The function w is a solution of the boundary value problem

$$-\Delta w + w = 0 \quad \text{in } \Omega, \tag{3.6}$$

$$\frac{\partial w}{\partial \nu} + \alpha w = (\tilde{\alpha} - \alpha)\tilde{u} \quad \text{on } \Gamma. \tag{3.7}$$

It follows from (3.6), (3.7) that

$$\int_{\Omega} (|\nabla w|^2 + w^2)dx + \alpha \int_{\Gamma} w^2 ds = (\alpha - \tilde{\alpha}) \int_{\Gamma} w \tilde{u} ds.$$

Thence, for $\alpha > \alpha_1 > 0$

$$\int_{\Omega} (|\nabla w|^2 + w^2)dx + \frac{\alpha}{2} \int_{\Gamma} w^2 ds \leq \frac{(\tilde{\alpha} - \alpha)^2}{2\alpha} \int_{\Gamma} \tilde{u}^2 ds \leq C_4 (\tilde{\alpha} - \alpha)^2 \|\tilde{u}\|_{H^1(\Omega)}^2$$

and

$$\|w\|_{H^1(\Omega)} \leq C_5 |\tilde{\alpha} - \alpha| \|\tilde{u}\|_{H^1(\Omega)}.$$

Consequentially,

$$\|(A_{\tilde{\alpha}} - A_\alpha)h\|_{L_2(\Omega)} \leq C_5 |\tilde{\alpha} - \alpha| \|\tilde{u}\|_{H^1(\Omega)}.$$

Now, applying the estimate (3.4) for $h \in L_2(\Omega)$ we have the inequalities

$$\begin{aligned} \|(A_{\tilde{\alpha}} - A_\alpha)h\|_{L_2(\Omega)} &\leq C_5 |\tilde{\alpha} - \alpha| \|h\|_{L_2(\Omega)}, \\ \|A_{\tilde{\alpha}} - A_\alpha\| &\leq C_5 |\tilde{\alpha} - \alpha|, \quad \alpha, \tilde{\alpha} > \alpha_1. \end{aligned} \tag{3.8}$$

Then by the inequalities (3.1), (3.8) we get

$$|\mu_k(\tilde{\alpha}) - \mu_k(\alpha)| \leq C_5 |\tilde{\alpha} - \alpha|.$$

Therefore,

$$|\lambda_k(\tilde{\alpha}) - \lambda_k(\alpha)| \leq C_5 (\lambda_k(\tilde{\alpha}) + 1) (\lambda_k(\alpha) + 1) |\tilde{\alpha} - \alpha|. \quad (3.9)$$

Furthermore, consider the Dirichlet problem

$$-\Delta v + v = h \quad \text{in } \Omega, \quad (3.10)$$

$$v = 0 \quad \text{on } \Gamma. \quad (3.11)$$

We define the linear operator A^D by

$$A^D : L_2(\Omega) \rightarrow \mathring{H}^1(\Omega) \subset L_2(\Omega), \quad \text{for } h \mapsto v.$$

The operator A^D is a self-adjoint positive compact operator in $L_2(\Omega)$ ([8], Section 4) and $\|A^D\| = 1/(\lambda_1^D + 1) < 1$. We have

$$(\lambda_k^D + 1)A^D u_k^D = u_k^D,$$

therefore

$$\mu_k^D = 1/(\lambda_k^D + 1), \quad k = 1, 2, \dots \quad (3.12)$$

are the eigenvalues of A^D with the eigenfunctions $u_k^D \in \mathring{H}^1(\Omega)$.

Let $w = (A^D - A_\alpha)h = v - u$. By (3.2), (3.3), (3.10), (3.11) the function w is a solution of the boundary value problem

$$-\Delta w + w = 0 \quad \text{in } \Omega, \quad w = \frac{1}{\alpha} \frac{\partial u}{\partial \nu} \quad \text{on } \Gamma,$$

where $u = A_\alpha h \in H^2(\Omega)$ ([15], Chapter 4, Section 2, Theorem 4). Due to elliptic regularity ([2], Par. 11.1d) we have the estimate

$$\|w\|_{H^1(\Omega)} \leq \frac{C_6}{\alpha} \left\| \frac{\partial u}{\partial \nu} \right\|_{H^{1/2}(\Gamma)}$$

and consequently by the embedding theorem for Sobolev spaces ([2], Theorem 5.1.7)

$$\|(A^D - A_\alpha)h\|_{L_2(\Omega)} \leq \frac{C_7}{\alpha} \|u\|_{H^2(\Omega)}.$$

Now, applying the estimate (3.4) for $h \in L_2(\Omega)$, we have the following inequalities

$$\|(A^D - A_\alpha)h\|_{L_2(\Omega)} \leq \frac{C_3 C_7}{\alpha} \|h\|_{L_2(\Omega)}, \quad \|A^D - A_\alpha\| \leq \frac{C_3 C_7}{\alpha}, \quad \alpha > \alpha_1. \quad (3.13)$$

Then by the equalities (3.5), (3.12) and the inequalities (3.1), (3.13) we get the estimate

$$|\mu_k^D - \mu_k(\alpha)| \leq C_3 C_7 / \alpha.$$

Therefore,

$$|\lambda_k^D - \lambda_k(\alpha)| \leq \frac{C_3 C_7}{\alpha} (\lambda_k^D + 1)(\lambda_k(\alpha) + 1)$$

and taking into account the inequalities $\lambda_k(\alpha) \leq \lambda_k^D$, we obtain

$$0 \leq \lambda_k^D - \lambda_k(\alpha) \leq \frac{C_3 C_7}{\alpha} (\lambda_k^D + 1)^2 \leq \frac{C_2}{\alpha} (\lambda_k^D)^2. \tag{3.14}$$

Proof of Theorem 1. Let $m = m(\lambda_k^D)$ and

$$\lambda_{k-1}^D < \lambda_k^D = \lambda_{k+1}^D = \dots = \lambda_{k+m-1}^D < \lambda_{k+m}^D. \tag{3.15}$$

Now we consider the eigenvalues $\lambda_j(\alpha)$, $j = k, k + 1, \dots, k + m - 1$ as functions of the variable α . It follows from (3.14) and (3.15) that for any $\varepsilon > 0$ there exists $\alpha_k \in \mathbb{R}$ such that for all $\alpha > \alpha_k$ the following inequalities hold

$$\lambda_j(\alpha) < \lambda_{k-1}^D + \varepsilon, \quad j = 1, 2, \dots, k - 1, \tag{3.16}$$

$$\lambda_j(\alpha) > \lambda_{k+m}^D - \varepsilon, \quad j = k + m, k + m + 1, \dots \tag{3.17}$$

Let $\varepsilon = \min\{|\lambda_k^D - \lambda_{k-1}^D|, |\lambda_{k+m}^D - \lambda_k^D|\}/2$. Then by (3.16), (3.17) for $\alpha > \alpha_k$ the interval $(\lambda_k^D - \varepsilon, \lambda_k^D + \varepsilon)$ contains only the eigenvalues $\lambda_j(\alpha)$, $j = k, \dots, k + m - 1$. The other eigenvalues of the problem (1.1), (1.2) are located outside of this interval. Thus, for any $\alpha > \alpha_k$ only the functions $\lambda_j(\alpha)$, $j = k, \dots, k + m - 1$ can be equal and a number of such functions does not exceeds m . Theorem 1 is proved. \square

4 Perturbation of eigenvectors: abstract model

Consider a real Hilbert space H with the scalar product (\cdot, \cdot) and the norm $\|\cdot\|$. Let e and g be non-zero elements in H .

DEFINITION 1. The non-negative number

$$\delta(e, g) = \sqrt{1 - (e, g)^2 / \|e\|^2 \|g\|^2} \tag{4.1}$$

is called a deviation between e and g .

It follows from (4.1) that $0 \leq \delta(e, g) \leq 1$, $\delta(e, g) = \delta(g, e)$, $\delta(e, g) \leq \delta(e, h) + \delta(h, g)$ and the linear spans of e and g coincides if and only if $\delta(e, g) = 0$. Therefore, the deviation is a metric on the set of one-dimensional linear subspaces of H .

Lemma 1. *Let $(e, g) \geq 0$. Then the following estimate holds:*

$$\|e/\|e\| - g/\|g\|\| \leq \sqrt{2}\delta(e, g).$$

Proof of Lemma 1.

$$\begin{aligned} \|e/\|e\| - g/\|g\|\|^2 &= 2(1 - (e, g)/\|e\|\|g\|) \\ &= 2\delta^2(e, g)/(1 + (e, g)/\|e\|\|g\|) \leq 2\delta^2(e, g). \end{aligned}$$

\square

Let A be a linear compact self-adjoint positive operator in H . Let $\{\mu_j\}_{j=1}^{\infty}$ be a sequence of its eigenvalues and $\{e_j\}_{j=1}^{\infty}$ be an orthonormal basis of corresponding eigenvectors.

DEFINITION 2. The number $\varrho_k^A = \inf_{j \neq k} |\mu_j - \mu_k|$ is called an isolation distance of the eigenvalue μ_k .

The following Lemma 2 generalizes Lemma 1 from [10].

Lemma 2. *Let $z \in H$ and $z \neq 0$. Then for any $k = 1, 2, \dots$ we have*

$$\|(A - \mu_k I)z\| \geq \varrho_k^A \delta(z, e_k) \|z\|.$$

Proof of Lemma 2. Let $z = \sum_{j=1}^{\infty} a_j e_j$. Then

$$\begin{aligned} \|(A - \mu_k I)z\|^2 &= \left\| \sum_{j=1}^{\infty} (\mu_j - \mu_k) a_j e_j \right\|^2 \\ &= \sum_{\substack{j=1 \\ j \neq k}}^{\infty} (\mu_j - \mu_k)^2 a_j^2 \geq (\varrho_k^A)^2 \sum_{\substack{j=1 \\ j \neq k}}^{\infty} a_j^2 = (\varrho_k^A)^2 (\|z\|^2 - a_k^2). \end{aligned} \quad (4.2)$$

It follows from (4.1) that $a_k^2 = (1 - \delta^2(z, e_k)) \|z\|^2$, so, apply this to (4.2), we obtain $\|(A - \mu_k I)z\|^2 \geq (\varrho_k^A)^2 \delta^2(z, e_k) \|z\|^2$. Lemma 2 is proved. \square

Let A and B be two linear compact self-adjoint positive operators in H with the sequences of eigenvalues $\{\mu_j^A\}_{j=1}^{\infty}$, $\{\mu_j^B\}_{j=1}^{\infty}$ and orthonormal bases of eigenvectors $\{e_j\}_{j=1}^{\infty}$, $\{g_j\}_{j=1}^{\infty}$.

Theorem 7. *Let for some k holds $\max\{\varrho_k^A, \varrho_k^B\} > 0$. Then*

$$\delta(e_k, g_k) \leq \frac{2}{\max\{\varrho_k^A, \varrho_k^B\}} \|A - B\|. \quad (4.3)$$

Proof of Theorem 7. We have the equality

$$(A - \mu_k^A I)(g_k - (e_k, g_k)e_k) = (A - B)g_k + (\mu_k^B - \mu_k^A)g_k. \quad (4.4)$$

Since $\|e_k\| = \|g_k\| = 1$ we obtain

$$\delta(e_k, g_k) = \sqrt{1 - (e_k, g_k)^2} = \|g_k - (e_k, g_k)e_k\|. \quad (4.5)$$

Now, if $g_k = (e_k, g_k)e_k$, then $\delta(e_k, g_k) = 0$ and the inequality (4.3) holds. Otherwise, $(g_k - (e_k, g_k)e_k, e_k) = 0$ so $\delta(g_k - (e_k, g_k)e_k, e_k) = 1$ and by equalities (4.4), (4.5) and Lemma 2 we obtain

$$\begin{aligned} \delta(e_k, g_k) &\leq \frac{1}{\varrho_k^A} \|(A - \mu_k^A I)(g_k - (e_k, g_k)e_k)\| \\ &\leq \frac{1}{\varrho_k^A} (\|A - B\| + |\mu_k^A - \mu_k^B|). \end{aligned}$$

Thence, by the Theorem 5

$$\delta(e_k, g_k) \leq \frac{2}{\varrho_k^A} \|A - B\|. \tag{4.6}$$

Interchange operators A and B in (4.6), we have

$$\delta(e_k, g_k) \leq \frac{2}{\varrho_k^B} \|A - B\|. \tag{4.7}$$

Combine estimates (4.6) and (4.7), we finally obtain

$$\delta(e_k, g_k) \leq \frac{2}{\max\{\varrho_k^A, \varrho_k^B\}} \|A - B\|.$$

This completes the proof of Theorem 7. \square

5 Convergence of eigenfunctions

For $\tilde{\alpha}, \alpha \in \mathbb{R}$ we suppose $\int_{\Omega} u_{k,\tilde{\alpha}} u_{k,\alpha} dx \geq 0$.

Lemma 3. *Let $m(\lambda_k^D) = 1$. Then there exists the number $\alpha_k \in \mathbb{R}$ such that for all $\tilde{\alpha}, \alpha > \alpha_k$ we have $m(\lambda_k(\alpha)) = 1$ and the following inequality holds*

$$\|u_{k,\tilde{\alpha}} - u_{k,\alpha}\|_{H^2(\Omega)} \leq C_8 |\tilde{\alpha} - \alpha|.$$

Proof of Lemma 3. It follows from the equality $m(\lambda_k^D) = 1$ and the Theorem 1 that $\varrho_k^{A_\alpha} > 0, \alpha > \alpha_k$ for some α_k . By the estimates (3.8) and (4.3), applying Theorem 7 for $H = L_2(\Omega)$ with $A = A_{\tilde{\alpha}}, B = A_\alpha$, we get

$$\delta(u_{k,\tilde{\alpha}}, u_{k,\alpha}) \leq \frac{2}{\varrho_k^{A_\alpha}} \|A_{\tilde{\alpha}} - A_\alpha\| \leq \frac{2C_5}{\varrho_k^{A_\alpha}} |\tilde{\alpha} - \alpha|. \tag{5.1}$$

Thence, it follows from (5.1) and Lemma 1 that

$$\|u_{k,\tilde{\alpha}} - u_{k,\alpha}\|_{L_2(\Omega)} \leq \frac{2\sqrt{2}C_5}{\varrho_k^{A_\alpha}} |\tilde{\alpha} - \alpha|. \tag{5.2}$$

Now, we have the problems

$$\Delta u_{k,\tilde{\alpha}} + \lambda_k(\tilde{\alpha})u_{k,\tilde{\alpha}} = 0 \quad \text{in } \Omega, \quad \frac{\partial u_{k,\tilde{\alpha}}}{\partial \nu} + \tilde{\alpha}u_{k,\tilde{\alpha}} = 0 \quad \text{on } \Gamma, \tag{5.3}$$

$$\Delta u_{k,\alpha} + \lambda_k(\alpha)u_{k,\alpha} = 0 \quad \text{in } \Omega, \quad \frac{\partial u_{k,\alpha}}{\partial \nu} + \alpha u_{k,\alpha} = 0 \quad \text{on } \Gamma. \tag{5.4}$$

By (5.3) – (5.4) the function $w = u_{k,\tilde{\alpha}} - u_{k,\alpha}$ is a solution of the boundary value problem

$$\begin{aligned} -\Delta w + w &= (\lambda_k(\alpha) + 1)w + (\lambda_k(\tilde{\alpha}) - \lambda_k(\alpha))u_{k,\alpha} && \text{in } \Omega, \\ \frac{\partial w}{\partial \nu} + \alpha w &= (\alpha - \tilde{\alpha})u_{k,\tilde{\alpha}} && \text{on } \Gamma. \end{aligned}$$

Let us note that by ([1], Theorem 15.2) the following estimate holds

$$\begin{aligned} \|w\|_{H^2(\Omega)} &\leq C_9((\lambda_k(\alpha) + 1)\|w\|_{L_2(\Omega)} \\ &\quad + |\lambda_k(\tilde{\alpha}) - \lambda_k(\alpha)|\|u_{k,\alpha}\|_{L_2(\Omega)} + |\tilde{\alpha} - \alpha|\|u_{k,\tilde{\alpha}}\|_{H^{1/2}(\Gamma)}) \end{aligned} \quad (5.5)$$

with the constant C_9 depends on Ω . Thence, by the embedding theorem ([2], Theorem 5.1.7) we get

$$\|u\|_{H^{1/2}(\Gamma)} \leq C_{10}\|u\|_{H^1(\Omega)}, \quad u \in H^1(\Omega) \quad (5.6)$$

and with the inequalities (3.9), (5.2), (5.5) we obtain

$$\|w\|_{H^2(\Omega)} \leq C_{11}|\tilde{\alpha} - \alpha|$$

with the constant C_{11} depends on k . Lemma 3 is proved. \square

Proof of Theorem 4. Let $m(\lambda_k^D) = 1$ (the eigenvalue λ_k^D is simple). By the estimates (3.13) and (4.3), applying Theorem 7 for $H = L_2(\Omega)$ with $A = A^D$, $B = A_\alpha$ we get

$$\delta(u_k^D, u_{k,\alpha}) \leq \frac{2}{\varrho_k^{A^D}}\|A^D - A_\alpha\| \leq \frac{2C_3C_7}{\varrho_k^{A^D}\alpha}, \quad \alpha > \alpha_1. \quad (5.7)$$

Therefore, for normalized in $L_2(\Omega)$ eigenfunctions u_k^D and $u_{k,\alpha}$ such that $\int_\Omega u_{k,\alpha} u_k^D dx \geq 0$ it follows from (5.7) and Lemma 1 that

$$\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} \leq \frac{2\sqrt{2}C_3C_7}{\varrho_k^{A^D}\alpha}, \quad \alpha > \alpha_1. \quad (5.8)$$

Now, we have the problems

$$\Delta u_{k,\alpha} + \lambda_k(\alpha)u_{k,\alpha} = 0 \quad \text{in } \Omega, \quad \frac{\partial u_{k,\alpha}}{\partial \nu} + \alpha u_{k,\alpha} = 0 \quad \text{on } \Gamma, \quad (5.9)$$

$$\Delta u_k^D + \lambda_k^D u_k^D = 0 \quad \text{in } \Omega, \quad u_k^D = 0 \quad \text{on } \Gamma. \quad (5.10)$$

By (5.9) – (5.10) the function $w = u_k^D - u_{k,\alpha}$ is a solution of the boundary value problem

$$\begin{aligned} -\Delta w + w &= (\lambda_k^D + 1)(u_k^D - u_{k,\alpha}) + (\lambda_k^D - \lambda_k(\alpha))u_{k,\alpha} \quad \text{in } \Omega, \\ w &= \frac{1}{\alpha} \frac{\partial u_{k,\alpha}}{\partial \nu} \quad \text{on } \Gamma. \end{aligned}$$

Besides, the function

$$\tilde{w} = w - \frac{1}{\alpha}(b, \nabla u_{k,\alpha}), \quad b(x) = (b_1(x), \dots, b_n(x)) \in C^2(\overline{\Omega}), \quad b|_\Gamma = \nu$$

is a solution of the problem

$$-\Delta \tilde{w} + \tilde{w} = h_{k,\alpha} \quad \text{in } \Omega, \quad \tilde{w} = 0 \quad \text{on } \Gamma,$$

where

$$\begin{aligned}
 h_{k,\alpha} &= (\lambda_k^D + 1) (u_k^D - u_{k,\alpha}) + (\lambda_k^D - \lambda_k(\alpha)) u_{k,\alpha} \\
 &\quad + \frac{1}{\alpha} ((b, \nabla u_{k,\alpha}) - \Delta(b, \nabla u_{k,\alpha})) \\
 &= (\lambda_k^D + 1) (u_k^D - u_{k,\alpha}) + (\lambda_k^D - \lambda_k(\alpha)) u_{k,\alpha} \\
 &\quad + \frac{1}{\alpha} \left((b, \nabla u_{k,\alpha}) - (\Delta b, \nabla u_{k,\alpha}) - 2 \sum_{i,j=1}^n (b_j)_{x_i} (u_{k,\alpha})_{x_j} - (b, \nabla \Delta u_{k,\alpha}) \right) \\
 &= (\lambda_k^D + 1) (u_k^D - u_{k,\alpha}) + (\lambda_k^D - \lambda_k(\alpha)) u_{k,\alpha} \\
 &\quad + \frac{1}{\alpha} \left((b - \Delta b, \nabla u_{k,\alpha}) - 2 \sum_{i,j=1}^n (b_j)_{x_i} (u_{k,\alpha})_{x_i x_j} + \lambda_k(\alpha) (b, \nabla u_{k,\alpha}) \right) \\
 &= (\lambda_k^D + 1) (u_k^D - u_{k,\alpha}) + (\lambda_k^D - \lambda_k(\alpha)) u_{k,\alpha} \\
 &\quad + \frac{1}{\alpha} \left((1 + \lambda_k(\alpha)) b - \Delta b, \nabla u_{k,\alpha} - 2 \sum_{i,j=1}^n (b_j)_{x_i} (u_{k,\alpha})_{x_i x_j} \right). \tag{5.11}
 \end{aligned}$$

The eigenfunction $u_{k,\alpha}$ is a solution of the boundary problem

$$\begin{aligned}
 -\Delta u_{k,\alpha} + u_{k,\alpha} &= (\lambda_k(\alpha) + 1) u_{k,\alpha} && \text{in } \Omega, \\
 \frac{\partial u_{k,\alpha}}{\partial \nu} + \alpha u_{k,\alpha} &= 0 && \text{on } \Gamma
 \end{aligned}$$

and by (3.4) satisfies the estimate

$$\|u_{k,\alpha}\|_{H^2(\Omega)} \leq C_3(\lambda_k(\alpha) + 1), \quad \alpha > \alpha_1. \tag{5.12}$$

In domain with C^3 class boundary surface $u \in H^3(\Omega)$ ([15], Chapter 4, Section 2, Theorem 4). Further we need an elliptic estimate to solution u of the problem (3.2), (3.3):

$$\|u\|_{H^3(\Omega)} \leq C_{12} \|h\|_{H^1(\Omega)}, \quad \alpha > 0, \tag{5.13}$$

with the constant C_{12} is independent of α . The inequality (5.13) is obtained by the same method as the estimate (3.4) in ([9], P. 105–112). Let us give scheme of the proof. At first we denote:

$$|\nabla^p u|^2 = \sum_{j_1=1}^n \dots \sum_{j_p=1}^n u_{x_{j_1} \dots x_{j_p}}^2.$$

For any function $u \in C^4(\Omega) \cap C^3(\bar{\Omega})$ consider the equality

$$|\nabla^3 u|^2 = |\nabla \Delta u|^2 + \operatorname{div} \left(\frac{1}{2} \nabla (|\nabla^2 u|^2) - \sum_{i=1}^n \Delta u_{x_i} \nabla u_{x_i} \right), \tag{5.14}$$

obtained by direct computation. Integrating the relation (5.14) on Ω and applying Gauss-Ostrogradskiy formula, we have the equality

$$\int_{\Omega} |\nabla^3 u|^2 dx = \int_{\Omega} |\nabla \Delta u|^2 dx + I, \tag{5.15}$$

where

$$I = \int_{\Gamma} \left(\frac{1}{2} \frac{\partial}{\partial \nu} (|\nabla^2 u|^2) - \sum_{j=1}^n \Delta u_{x_j} \frac{\partial}{\partial \nu} u_{x_j} \right) ds.$$

To obtain the equality (5.15) for $u \in C^3(\overline{\Omega})$ it is sufficient to take a limit in (5.15) for the sequence of functions $u_j \in C^4(\Omega) \cap C^3(\overline{\Omega})$ such that $\lim_{j \rightarrow \infty} \|u - u_j\|_{C^3(\overline{\Omega})} = 0$. Now, let $u \in C^3(\overline{\Omega})$ be a solution of the problem (3.2), (3.3). By (3.2) we get

$$\begin{aligned} \int_{\Omega} |\nabla^3 u|^2 dx &= \int_{\Omega} |\nabla(u - h)|^2 dx + I \\ &\leq 2 \left(\int_{\Omega} |\nabla u|^2 dx + \int_{\Omega} |\nabla h|^2 dx \right) + I. \end{aligned} \quad (5.16)$$

Moreover, we have the energy estimate ([9], Formula (35)):

$$\int_{\Omega} (|\nabla u|^2 + u^2) dx + \alpha \int_{\Gamma} u^2 ds \leq \int_{\Omega} h^2 dx, \quad \alpha > 0 \quad (5.17)$$

and the following inequality ([9], see Formulas (37), (39), (49), (54))

$$\begin{aligned} \int_{\Omega} |\nabla^2 u|^2 dx + \alpha \int_{\Gamma} |\nabla_{\tau} u|^2 ds \\ \leq \int_{\Omega} (\Delta u)^2 dx + (n-1) \int_{\Gamma} H(x) \left(\frac{\partial u}{\partial \nu} \right)^2 ds, \end{aligned} \quad (5.18)$$

$$\alpha > \max_{x \in \Gamma} \max_{1 \leq j \leq n-1} |k_j(x)|,$$

where the vector $\nabla_{\tau} u = \nabla u - \frac{\partial u}{\partial \nu} \nu$ is a tangential gradient of the function u on the surface Γ , $H(x)$ is a mean curvature and $k_j(x)$ are main curvatures of Γ oriented by outward normal at the point x . To estimate the surface integral I in (5.16) we will consider the element of integration in the local orthogonal coordinate system in the arbitrary point $x \in \Gamma$ such that n th axe direction coincides with ν and the origin is in x . Then, transforming I by the technique of ([13], Chapter 1, Section 7, Lemmas 1, 2', 3, Chapter 2, Section 3, Lemma 1'; [18]; [9]), with the estimates (5.17), (5.18) we obtain from (5.16) the inequality

$$\int_{\Omega} |\nabla^3 u|^2 dx \leq C_{13} \int_{\Omega} (|\nabla h|^2 + h^2) dx, \quad \alpha > 0 \quad (5.19)$$

with the constant C_{13} is independent of α . Combine (3.4) and (5.19), we get the estimate (5.13) for solutions of the problem (3.2), (3.3) from $C^3(\overline{\Omega})$. To prove the estimate (5.13) for solutions from $H^3(\Omega)$ we take a sequence of functions $u_j \in C^3(\overline{\Omega})$ satisfying (3.3) such that $\|u - u_j\|_{H^3(\Omega)} \rightarrow 0$, $j \rightarrow \infty$. Applying the estimate (5.19) to the functions u_j we have

$$\|u_j\|_{H^3(\Omega)} \leq C_{12} \|h_j\|_{H^1(\Omega)}, \quad \alpha \geq \alpha_1, \quad (5.20)$$

where $h_j = -\Delta u_j + u_j$. Therefore, $\lim_{j \rightarrow \infty} \|h_j\|_{H^1(\Omega)} = \|h\|_{H^1(\Omega)}$. Taking a limit in (5.20), we obtain the inequality (5.13) for solutions $u \in H^3(\Omega)$.

Combining (1.7), (5.11) and (5.12), we obtain the estimate

$$\begin{aligned} \|h_{k,\alpha}\|_{L_2(\Omega)} &\leq (\lambda_k^D + 1)\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} \\ &\quad + (\lambda_k^D - \lambda_k(\alpha))\|u_{k,\alpha}\|_{L_2(\Omega)} + \frac{C_{14}}{\alpha}\|u_{k,\alpha}\|_{H^2(\Omega)} \\ &\leq C_{15}\left(\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} + \frac{1}{\alpha}\right), \quad \alpha > \alpha_1, \end{aligned} \tag{5.21}$$

where the constant C_{15} is independent of α , but may depend on k . It follows from the inequality ([15], Chapter 4, Section 2, Theorem 4) that

$$\|\tilde{w}\|_{H^2(\Omega)} \leq C_{16}\left(\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} + \frac{1}{\alpha}\right), \quad \alpha > \alpha_1. \tag{5.22}$$

Combining (5.8), (5.13), (5.21) with (5.22), we get

$$\begin{aligned} \|u_k^D - u_{k,\alpha}\|_{H^2(\Omega)} &= \left\| \tilde{w} + \frac{1}{\alpha}(b, \nabla u_{k,\alpha}) \right\|_{H^2(\Omega)} \\ &\leq \|\tilde{w}\|_{H^2(\Omega)} + \frac{1}{\alpha} \|(b, \nabla u_{k,\alpha})\|_{H^2(\Omega)} \\ &\leq C_{16}\left(\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} + \frac{1}{\alpha}\right) + \frac{C_{17}}{\alpha}\|u_{k,\alpha}\|_{H^3(\Omega)} \\ &\leq C_{16}\left(\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} + \frac{1}{\alpha}\right) + (\lambda_k^D + 1)\frac{C_{12}C_{17}}{\alpha}\|u_{k,\alpha}\|_{H^1(\Omega)} \\ &\leq C_{16}\left(\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} + \frac{1}{\alpha}\right) + (\lambda_k^D + 1)^{3/2}\frac{C_{12}C_{17}}{\alpha} \\ &\leq C_{18}\left(\|u_k^D - u_{k,\alpha}\|_{L_2(\Omega)} + \frac{1}{\alpha}\right) \leq \frac{M_k}{\alpha}, \quad \alpha > \alpha_1 \end{aligned} \tag{5.23}$$

with the constant M_k independent on α . Theorem 4 is proved. \square

6 Derivative of eigenvalue and asymptotic expansion

Proof of Theorem 2. For eigenfunctions $u_{k,\alpha}$, $u_{k,\alpha'}$ we have the equalities

$$\begin{aligned} \int_{\Omega} ((\nabla u_{k,\alpha'}, \nabla u_{k,\alpha}) - \lambda_k(\alpha')u_{k,\alpha'}u_{k,\alpha})dx &= -\alpha' \int_{\Gamma} u_{k,\alpha'}u_{k,\alpha}ds, \\ \int_{\Omega} ((\nabla u_{k,\alpha}, \nabla u_{k,\alpha'}) - \lambda_k(\alpha)u_{k,\alpha}u_{k,\alpha'})dx &= -\alpha \int_{\Gamma} u_{k,\alpha}u_{k,\alpha'}ds. \end{aligned}$$

Therefore,

$$\frac{\lambda_k(\alpha') - \lambda_k(\alpha)}{\alpha' - \alpha} = \frac{\int_{\Gamma} u_{k,\alpha'}u_{k,\alpha}ds}{\int_{\Omega} u_{k,\alpha'}u_{k,\alpha}dx}. \tag{6.1}$$

Now, suppose that $\int_{\Omega} u_{k,\alpha}u_{k,\alpha'}dx \geq 0$. By Lemma 3 and inequality (5.6) we obtain from (6.1) that

$$\lambda'_k(\alpha) = \lim_{\alpha' \rightarrow \alpha} \frac{\int_{\Gamma} u_{k,\alpha'}u_{k,\alpha}ds}{\int_{\Omega} u_{k,\alpha'}u_{k,\alpha}dx} = \frac{\int_{\Gamma} u_{k,\alpha}^2 ds}{\int_{\Omega} u_{k,\alpha}^2 dx}.$$

Theorem 2 is proved. \square

Proof of Theorem 3. Let $m(\lambda_k^D) = 1$. We suppose $\int_{\Omega} u_{k,\alpha} u_k^D dx \geq 0$. For the normalized eigenfunction u_k^D the relation (2.2) is equivalent to

$$\lim_{\alpha \rightarrow +\infty} \frac{\lambda_k(\alpha) - \lambda_k^D}{1/\alpha} = - \int_{\Gamma} \left(\frac{\partial u_k^D}{\partial \nu} \right)^2 ds. \quad (6.2)$$

Let us note that the numerator $\lambda_k(\alpha) - \lambda_k^D$ in the fraction in (6.2) by (1.7) tends to zero at $\alpha \rightarrow +\infty$. By the formula (2.1) and the boundary condition (1.2) we have

$$\lambda_k'(\alpha) = \int_{\Gamma} u_{k,\alpha}^2 ds = \frac{1}{\alpha^2} \int_{\Gamma} \left(\frac{\partial u_{k,\alpha}}{\partial \nu} \right)^2 ds.$$

Therefore,

$$\lim_{\alpha \rightarrow +\infty} \frac{\lambda_k'(\alpha)}{-1/\alpha^2} = - \lim_{\alpha \rightarrow +\infty} \int_{\Gamma} \left(\frac{\partial u_{k,\alpha}}{\partial \nu} \right)^2 ds. \quad (6.3)$$

Let us prove that

$$\lim_{\alpha \rightarrow +\infty} \int_{\Gamma} \left(\frac{\partial u_{k,\alpha}}{\partial \nu} \right)^2 ds = \int_{\Gamma} \left(\frac{\partial u_k^D}{\partial \nu} \right)^2 ds. \quad (6.4)$$

By the inequality (5.23) and the embedding theorem ([2], Theorem 5.1.7) we have

$$\begin{aligned} \int_{\Gamma} \left(\frac{\partial u_k^D}{\partial \nu} - \frac{\partial u_{k,\alpha}}{\partial \nu} \right)^2 ds &\leq \int_{\Gamma} |\nabla(u_k^D - u_{k,\alpha})|^2 ds \\ &\leq C_{19} (\|\nabla^2(u_k^D - u_{k,\alpha})\|_{L_2(\Omega)}^2 + \|\nabla(u_k^D - u_{k,\alpha})\|_{L_2(\Omega)}^2) \\ &\leq C_{19} \|u_k^D - u_{k,\alpha}\|_{H^2(\Omega)} \leq C_{19} M_k / \alpha \rightarrow 0, \quad \alpha \rightarrow +\infty. \end{aligned} \quad (6.5)$$

Using (6.5), we obtain the relation (6.4). Now, by L'Hôpital-Bernoulli theorem the equality (6.2) follows from (6.3). Proof of the Theorem 3 is completed. \square
